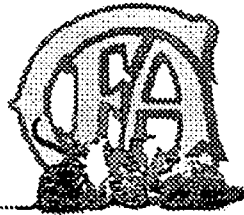

SPECIAL ENTRY INFORMATION: Entry clerk will phone collect to clarify entries where necessary. Fees must accompany entries and no fees will be refunded due to failure to bench. No postdated checks will be accepted. There will a \$35.00 fee charged on all returned checks. In the event the show fills before closing, the club will accept entries for a waiting list as follows: Any entry received with payment in full, followed by fax and email entries with a time and date header. Please note groom spaces are limited to the first 20 paid requests; a waiting list will be started if additional requests are received. Should the show fail to fill, additional groom spaces will be added as space allows, beginning with paid grooms from the waiting list.

ENTRY FEES: Make checks payable to *LCCC/GCCC*. First entry fee includes show catalog. End of Row benching is as available (no charge to disabled exhibitors.)

CLOSING DATE: September 13, 2010 OR WHEN LIMIT IS REACHED.

HEALTH: This is a non-vetted show. It is strongly recommended that all entries be tested for feline leukemia and inoculated for protection against feline enteritis, rhinotracheitis, calci virus and chlamydia. All entries must be free of fungus and parasites, EACH ENTRY MUST HAVE ALL CLAWS CLIPPED. Declawed cats are not eligible for entry.

CAGES: Cages are California singles, 36"wide, 24" deep and 27" high. No more than one cat or two kittens may be benched in the same cage. Any exhibitor using a security cage larger than 36" long MUST purchase a groom space.

AWARDS: Ribbons and rosettes will be awarded in accordance with CFA show rules. Permanent flats will be used with satin flats available upon request. For a copy of the current CFA Show Rules, send \$7.00 to The Cat Fanciers' Association, P.O. Box 1005, Manasquan, NJ 08736-1005.

SHOW HOURS: Check in will be 7:30a.m.-8:30a.m.; show hours will be 9:00a.m. – 4:00p.m. both days.

SHOW HALL INFORMATION: The Palm Springs Leisure Center, 401S. Pavilion Way, free parking. Smoking is not permitted in the show hall. The hall is climate controlled. Show Hall and facilities are handicapped accessible. Mark Campbell will be on kitchen duty with breakfast and lunch for both days!

SHOW HOTELS: Pet friendly hotels in Palm Springs include the Holiday Inn, Vagabond, Motel 6, Palm Mountain Resort and Spa and the Hyatt Regency.
