**SHOW HOTEL:** There is no official show hotel. Below are some suggested motels.

**SHOW HALL:** El Zaribah Shrine Auditorium, 552 North 40<sup>th</sup> Street, Phoenix, AZ. The show hall is climate controlled with heat and/or air conditioning and is also handicap accessible. **This is a non-smoking hall.** Food will be available inside the hall with a "full service" bar adjacent to the show hall in a separate room. No alcohol or outside food is permitted in the show hall.

**Directions From CA:** I-10 East to 202 East. Exit at 40<sup>th</sup> St. & turn right. Show hall is approx. 1 block on right, behind Frito-Lay building.

**Directions From Tucson:** I-10 West to 143 North. Exit at Washington & turn left. Right on 40<sup>th</sup> St. Show hall is on left, just north of Van Buren and behind Frito-Lay building.

**BENCHING:** Single cage size is 22" x 27" x 22". Double cage is 22" x 54" x 22". No more than one cat or two kittens may be benched in a single cage. Every entry includes a single cage space. **Be aware that if you have an odd number of entries and do not purchase a double cage, another cat will be benched in the other half of the cage.** Litter will be provided. Bring your own cage drapes, bottom sheet, litter pans, food, and dishes.

**HEALTH:** This is a non-vetted show. All entries should be tested and found negative for FeLV and inoculated against feline enteritis, rhinotracheitis, calici viruses, and rabies. All entries must be free of fungus and parasites. All claws must be clipped prior to benching. De-clawed cats are not eligible for entry and will not be allowed in the show hall.

**HOUSEHOLD PETS:** Household pets must be 4 months of age or older on the first day of the show. Cats 8 months of age or older must be spayed or neutered. Cats should be bathed.

**VENDOR/CATALOG ADVERTISING:** Catalog advertising is: \$40/full page; \$20/half page; \$10/business card. Vending: 10x10 ft. space is \$35, each additional space is \$25 & electrical hook-up is \$25. For more vendor information and/or to request a vendor agreement form, contact Kim Taylore at 520-403-2685.

**AWARDS:** Ribbons and rosettes will be awarded in accordance with CFA Show Rules. Any donation to the ribbon and rosette fund will be appreciated and acknowledged in the catalog. Permanent 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place, Best and Second Best of Color Class, and Best and Second Best of Breed will be used. Fabric ribbons will be available on request.

**CFA RULES:** CFA show rules will be strictly enforced. The current CFA Show Rules are available online at <http://www.cfa.org/forms/manuals.html> and may be downloaded for free. A print copy may be obtained by sending \$7.00 to the Cat Fanciers' Association, P.O. Box 1005, Manasquan, NJ 08736-1005. All adult cats entered must be registered with CFA and their registration numbers included on the entry form. The entry clerk will phone collect to clarify entries where necessary. No fees will be refunded for failure to bench. Benching request will be honored wherever possible. **One benching request or agent per exhibitor.** No negative benching requests, please. The club reserves the right to add judges not named to judge non-championship and Household Pet classes. Kittens must be 4 months of age or older on the opening day of the show. Superstition Cat Fanciers, Inc and El Zaribah Shrine Auditorium will not be responsible for damage, loss, personal injury, or loss of personal property. No cats may be left overnight in the show hall. There will be no vending from cages or groom spaces. All Championship, Premiership, and registered kittens will be scored for CFA regional and national awards. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time.

**CHECK-IN AND JUDGING:** Check-in will be from 7:30 AM to 8:30 AM. Judging will begin promptly at 9:00 AM. Advertised show hours are 9:00 AM to 4:00 PM.

**NEW EXHIBITORS:** Superstition Cat Fanciers' members welcome you. If you are a new exhibitor, contact the show manager with any questions you may have. Please identify yourself at check-in and we will try to help you in any way we can to make this a pleasurable experience for you and your cat.

**GRAND PARTIES:** Grand parties are allowed only after the Shriners' food service is closed. Contact the Show Manager with any questions.
