

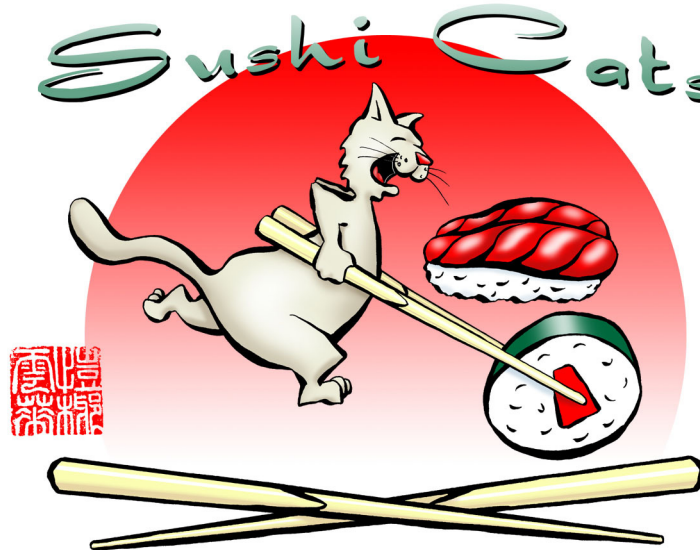

THE SHOW HALL is non-smoking and has central heating and air conditioning. People food will be available on the grounds for purchase. No outside food may be brought into the show hall. Sorry no Grand Parties.

CHECK-IN HOURS will be 8:30am to 9:30am. Any entry not checked in by 10:00am will be marked absent. Judging will begin promptly at 10:00 am on both days. The advertised hours are 10:00am to 7:00 pm Saturday, and 10:00am to 6:00pm Sunday. Exhibitors are expected to be present at the show during advertised hours.

HEALTH This is a non-vetted show. Exhibitors are urged to have all cats and kittens inoculated against Calici Virus, Feline Enteritis, Rhinotracheitis and tested for FeLV. All cats must be free from infections, ear mites, fleas and contagious diseases. Claws must be clipped. All kittens must be four months of age on or before the first day of the show.

CFA SHOW RULES will govern this show. A copy of the show rules can be obtained by sending \$5.00 to CFA, Inc., P.O. Box 1005, Manasquan, NJ 08736-1005. Rosettes will be awarded for all final wins. Permanent flats will be used; however, ribbons will be available at owner's request. All championship, premiership and registered kitten entries will be scored for CFA national and regional awards. The club reserves the right to add or change judges.

BENCHING REQUESTS will be limited to one exhibitor and will be honored when possible. No negative benching requests please. End of row benching requests will be honored as available, with fee waived for disabled exhibitors. A limited amount of groom space is available and will be offered on a first come, first served basis.

AMENITIES Litter will be provided but please bring your own litter pans. It is also suggested that you bring your own food and water bowls. Cage size will be 36" x 24" x 27". One cat or two kittens may be benched per cage. People bringing their own double cages will need to buy additional groom space to accommodate the difference in cage sizes.

NEW EXHIBITORS should bring a towel or rug for the floor of the cage and enough fabric to go around and cover the top of the cage. **ALL CATS MUST BE BROUGHT IN A CARRIER.** Declawed cats are not eligible for entry.

RAMADA LIMITED - 1680 Superior Ave., Costa Mesa, CA 92627 (Close to John Wayne / Orange County Airport and the show hall). Cut off date for block rooms is April 1, 2010. Please mention Sushi Cats for a room rate of \$76.00 per night for a regular room or \$106.00 for a suite. There is a \$100 pet fee, fully refundable upon room inspection. Every room has a small refrigerator and the suites have a microwave oven and a small sitting room. The Ramada will provide free shuttle service to and from Orange County Airport (SNA) from 7:30am to 10:30pm. Please call 949-645-2221 for reservations.

HILTON - Official Pet Expo Hotel, 3050 Bristol St., Costa Mesa, CA 92626. \$119.00 per night, \$50 non-refundable pet fee. Parking \$20.00 per day. Free shuttle service to and from Orange County Airport (SNA) from 5:30am to 11:00pm. Call 714-540-7000 for reservations.

ENTRIES AND FEES Make checks payable to Sushi Cats Cat Fanciers. Each entry must be on a signed CFA entry form or exact facsimile. For entry clarification, the entry clerk will call collect. Entry fees must be received within 10 days of submitting an entry.

DIRECTIONS TO THE SHOW HALL - Take the 405 or 5 freeway to the Costa Mesa Freeway (55) heading west. Exit at Fair Drive and turn right. Turn right at Fairview and then turn right at Arlington. Turn right again into the fairgrounds at gate 8, or as indicated by the parking attendant or signs. The parking attendant will direct you as to where to park.

To park close to building 14, arrive prior to the show opening at 10:00am. Those arriving after the start of show will be directed toward general parking. You will need a pass which will be provided with your conformation to enter the Pet Expo grounds and show hall. There is a \$5.00 per day parking fee or purchase a \$9.00 three day pass.

The OC Fair & Events Center, World Pet Association, America's Pet Expo, Sushi Cats Cat Fanciers, or individual club members shall not be liable for lost, stolen, or damaged property, nor personal injury due to attending the show.
